Community Health Education Report

If you watch television, use the Internet, read a newspaper or magazine, or volunteer at any health organization, the chances are almost 100% that you have heard the term opioid epidemic. The definition of epidemic is that which affects a disproportionately large number of individuals within a population. An opioid is a class of drugs with chemicals that are similar to our own endorphins produced

naturally to relieve pain. Opioids act on receptors in the spinal cord, gastrointestinal tract, and brain to reduce the intensity of pain perception, and affect brain areas that further diminish the effects of pain stimuli. Treatment for pain—this is a good thing, right?

Good if these drugs are used in the way intended at the dosage prescribed, but here's where the good ends. There is an epidemic of misuse—taking these drugs in higher amounts, for reasons other than their intended use resulting in poisoning or overdose.

According to a statement by the Centers for Disease Control, since 1999 the number of overdose deaths involving opioids and heroin quadrupled. From 2000 to 2015, more than half a million people died from drug overdoses. Ninety one Americans die every DAY from an opioid overdose.

Wisconsin hospitals and health systems applauded Governor Walker for the creation of the Governor's Task Force on Opioid Abuse. Representative John Nygren's HOPE Agenda and Attorney General Brad Schimel's Dose of Reality campaign have brought awareness to the urgency of identifying solutions to Wisconsin's dramatic rise in use and overdose deaths from heroin and opioid drugs in recent years. According to the report by the Office of Health Informatics, Division of Public Health, Wisconsin Department of Health Services, the rise was nearly 70 percent from 2005 to 2015.

Our CHE focus this year is the **opioid epidemic**. We can discuss how this impacts our hospitals, communities, and sadly many of our personal lives. We can learn what Wisconsin leaders, physicians and the public are doing toward awareness, prevention, and treatment. Take the pledge from the **Dose of Reality Campaign**: *I am concerned about the growing prescription painkiller abuse problem in Wisconsin. I pledge to use any medications I am prescribed only in the way they were intended by my doctor. I pledge to not share my prescriptions or use anybody else's. I pledge to safely and securely store my prescription painkillers or other medications and safely dispose of them when they are no longer needed or expired.* Because the reality is, **drugs end dreams**—of those who use drugs, of their friends, of their families, and of their communities.

2017 WHA Goals and Governor's Funding Support

WHA is in the process of developing their goals for 2017, which will be known later in February. However, some major Wisconsin WHA issues under discussion that are in process with Governor Walker and Wisconsin legislators that you might want to learn/be aware of are as noted in recent issues of Valued Voice: Governor Walker reiterated his support for funding three of WHA's key priorities—the Disproportionate Share Hospital Program (DSH), Graduate Medical Education (GME), and workforce initiatives.

"Obviously we are going to continue to support DSH payments. It is important, and for the state as a whole, we will continue to make that commitment as we have in the past," Walker said. "And, for the larger workforce needs, we support GME in rural and underserved areas, focusing on the appropriate level of support. Not just to attract physicians, but it is critically important that we keep them in these areas."
