## Meetings Were Plentiful

There has been an explosion of color and every imaginable shade of green can be seen. Summer is here! For me summer means happy times, memories to be made, watching the clouds drift by, and taking time to relax.

It has been a very busy March, April, and May. I am happy to have some down time to reflect and assimilate the information gathered during spring tour, Advocacy Day, and attending the American Hospital Association (AHA) meeting in Washington D.C. As always, Spring Tour was inspiring, educational, and thought provoking. I had the honor of installing three new district chairs and other district officers. It is extremely encouraging to see individuals willing to assume leadership positions so local organizations can remain active and vital. Thank you to each of the local organizations that hosted a district meeting and for presenting exceptional programs on issues that affect all of us.

While attending the AHA meeting, we had the opportunity to meet with WI representatives and senators. The WHA contingency addressed three main issues. These issues and WHA's positions are:

1. **Support 340B Program** – Congress may soon introduce proposals to reform the 340B program. Please recognize the value the 340B program provides and oppose any proposal that does further harm to the 340B program or attempts to add to hospitals' already complex regulatory burden.

2. **Support better treatment for opioid patients** – WHA strongly supports Congressional action to improve treatment for opioid addiction. WHA also encourages Congress to continue collaborating with hospitals and providers to examine workforce and regulatory issues that continue to be obstacles in treating opioid addiction.

3. **Support Stark Law Reform** – Ask legislators to sign onto the Stark Administrative Simplification Act of 2017 and HR 4206 – the Medicare Care Coordination Improvement Act of 2017 and explore additional ways to reduce the regulatory burden of the Stark Law.

These "hill" visits were extremely educational (and at times,

### A Message from the President-Elect

## Temporary Appointment

The death of Mary Licht last October was a great loss not only for her family and close friends, but for our Partners of WHA family as well. It was the first time that Partners has lost a sitting president, and the first time our President-Elect had to assume the presidency before the end of their own term as President-Elect. This created a vacancy in the office of President-Elect, and our Bylaws call for the Board to appoint someone to fill the vacancy, which is how I came to be President-Elect. However, our Bylaws also require our officers to be elected by the delegates at an Annual Meeting, so the President-Elect who the delegates elect October 3, 2018 will be installed at Convention and take office January 1, 2019. It will not be me, but I had two very good reasons to wish to fill this vacancy on a temporary basis. Reason One: I believed the appointment would give the appointee an advantage over other candidates. Because I will not be on the ballot, my appointment will not affect the election in October. Reason Two: I wanted to do the Bylaws presentations during Spring Tour. (A love of governance documents is a quirk, not a certifiable mental condition, so don't reserve that

## **Proposed Bylaws Included With this Issue of *Reaching Out***

During the Annual Meeting at the 2018 Partners of WHA Convention in October, a new set of Bylaws will be presented to replace the current Bylaws in their entirety. As discussed on the Spring Tour, there are only minor changes to the substance of the Bylaws. The major changes are simply to the order and format. Both the current and proposed Bylaws are available on the Partners of WHA website along with the PowerPoint from the Spring Tour presentation. In addition, there will be a conference call September 21 from 10-11 AM, which will allow an opportunity to ask questions that you may have.

**How do I access the conference call?** To participate in the phone conversation about the new Bylaws, go to the Partners of WHA website home page. At the very top right corner, you will see a description of the call with a link to the registration site. Click on the link. It will open a registration form through Survey Monkey. That will ask for your name and an email address. It will also give you a chance to submit a question. Two days before the call, you will receive an email with the toll-free phone number to call and an access code. A few minutes before the call, follow the instructions in the email to dial in. We encourage you to get together as a group, especially to have your delegates listen to the call. The presenters will answer the submitted questions first. ## Public Policy Education Report

Summer is here along with vacation time. I'm writing this article in late June since I'll be in Canada and western U.S. until July 17, past the deadline for including articles in this issue of *Reaching Out*. Plan and enjoy a vacation for yourself too – refreshes mind, body, and soul!

In the June 26 *Valued Voice*, we see that WHA President/CEO Eric Borgerding and his team at WHA are not slowing down in their efforts to assist and support Wisconsin hospitals. Sometimes summer can be a slow time of the year with Congress and Legislatures at both the federal and state level not in session. We are so fortunate and grateful

to them! Here are some of the things Eric and team are working on that we may want to keep an eye on and add our support for these WHA-supported initiatives by contacting both federal senate and house members. Watch for possible HEAT notices to respond to also.

**Opioid Reform:** On June 20, the U.S. House of Representatives passed two opioid reform measures that are expected to be taken up in the U.S. Senate in July 2018:

1. HR 6082, Overdose Prevention and patient Safety Act. This reform would align the patient behavioral health and substance use treatment records with HIPAA, making it easier to share critical health information with other health care providers and upgrade health care service outcomes in a more efficient and effective manner as well as reduce potential devastating outcomes for patients.
2. HR 5797, the IMD Care Act would open more treatment locations for opioid patients covered by Medicaid. This act would allow for Medicaid payment for opioid treatment services provided in Institutions of Mental Disease (IMDs) for up to 30 days of care. IMDs provide the best specialty care for opioid patients when and where they deserve it. Currently these patients mostly seek hospital emergency care, which is more costly and less specialized for their needs.

**Noteworthy for Rural Health Care Program telehealth services:** The Federal Communications Commission (FCC) increased an immediate \$171 million increase (to \$571 million), which was capped at \$400 million since 1997. The \$571 million will also be raised annually for inflation and any unused funds will be carried forward to future years. Telehealth capability is very important in providing health care services to patients in rural areas.

**Local Public Policy Education (PPE) Chairs - Calling Your Attention:** Are you gathering monthly advocacy contact statistics to legislators from your local board and general volunteer members? A form to gather the number and type of contact was shared during Spring Tour at your district meetings or contact me and I can email it to you. Your gentle inquiry also serves as a helpful reminder to all of us volunteers to take action by contacting our legislators on current issues that can help in providing high quality healthcare services. THANK YOU for your advocacy efforts and the results you can inspire!

## Community Health Education Report

At our spring district meetings, we discussed changing the stigma of Substance Use Disorder (SUD), recognizing drug dependence as a disease (classified by the American Medical Association), looking at studies of the brain showing chemical changes

when using substances, and recognizing that SUD can be treated, but it will be long-term treatment. Many of those with drug dependence also suffer from mental health issues. Addiction is a disease that knows no boundaries. It affects people from rural and urban areas, regardless of age or economic status. Senator Tammy Baldwin recently discussed her mother's long battle with opioid dependence. Former Green Bay Packers Hall of Famer Chester Marcol speaks openly about his 30-year struggle with drug and alcohol dependence, and attempted suicide (*USA Today Network – Wisconsin, March 2, 2018*). He is now an alcohol and drug abuse counselor and inspirational speaker.

When people stop using opioids, they experience severe withdrawal. Medications help a person through withdrawal, giving them the ability to consider healthier choices and work through counseling and other treatment. Methadone and Buprenorphine (Suboxone) are opioids used to reduce withdrawal symptoms and relieve cravings. Naltrexone (Vivitrol) helps block the effects of opioids so a person no longer feels the same high. But many treatment programs do not offer access to medication. Some patients choose not to use medications. The cost of medication and insurance prohibits treatment for many. Few doctors are trained in addiction medications, and many have not received federal waivers to prescribe buprenorphine, or may be reluctant to prescribe it without counseling and other wrap-around services available. Experts are looking at alternate medications, easier access to treatment medications, and training for doctors as potential ways to address the opioid crisis.

Relapse is frequently a part of recovery from dependence on drugs or alcohol. While "willpower" may have been a factor in the initial decision to use drugs, after a person becomes dependent on drugs, the chemical structure of the brain changes. The "willpower" to overcome the brain disease is not simple. If it were, we would not see the relapse rates we do. No reasonable person wants to be estranged from family, focused entirely on the next drug, or facing jail or prison. Treatment can dramatically improve the person's chance of sobriety. Studies show that 70 to 90 percent of

people who complete an addiction rehabilitation program will relapse at least once before they maintain sobriety for a period of time.

Successful treatment must include detoxification, inpatient and outpatient treatment, treatment medication, behavioral counseling, evaluation and treatment for mental health issues, and follow-up to prevent relapse. It's a long-term process, but is a person's life worth less?
