Safe Mobility is Fall Prevention

Hospital organizations can lead changes in patient-centered practices that are protective and promote patients' independence, function and social integration. Traditional fall prevention strategies that limit mobility can be repurposed for safe mobility, which ultimately reduces fall risk. Webinar participants will be introduced to strategies to profile the protective nature of care, while understanding and managing risk for those who require assisted mobility. Segmented high-vulnerable populations will be prioritized for individualized safe patient handling and mobility (SPHM), safe assisted mobility and fall prevention care practices, combined to improve safety and outcomes. In addition, this webinar targets those responsible for developing and implementing unit-based or facility-wide programs to reduce mobility-related adverse events.

Best Practices to Reduce Falls Associated with Toileting

Patients expect a safe environment when in our care. It is our shared responsibility as clinical providers to create an environment for safe toileting, individualized to one's changing needs. A safe environment reduces risk for harm when a fall occurs in bathrooms. Sufficient evidence confirms that falls in bathrooms are prevalent and dangerous, resulting in a duty within and across all hospitals to commit to reducing risk for falls and harm. This presentation is specifically designed to engage participants in strategies to reduce falls associated with all aspects of toileting. Participants will be inspired and guided to redesign fall prevention programs to mitigate and eliminate patient and environmental toileting fall risks and generate strategies for a population-based approach for scheduled and assisted toileting. preserve and advance patients' function and safety.

Redesigning Post Fall Management

All organizations strive for falls to be "never events" in healthcare. However, falls remain among the top adverse events patients experience in hospitals and nursing homes. When a fall occurs, efforts <u>must be</u> implemented to decrease the chance of reoccurrence based on the immediate cause of the fall. This imperative applies to determine sources of harm and intentional actions to elimination sources of harm. During this webinar, participants will affirm the vital role of a post fall huddle as a group consensus approach to determine the immediate/root cause of the fall; differentiate the post fall huddle from other post fall management components (incident reports and medical record documentation); and illustrate a post fall huddle program evaluation model.
