## Hospital Payment Rate Year 2020 Updates

- Description Model claims data extraction for rate setting purposes occurred week of March 27, 2019
- CMS HCRIS released by 03/31/2019 reflects the most currently available cost reports
- **Grouper versions updates:** 
  - APR DRG v36
  - EAPG v3.14

# **APR – DRG v36 CMI Normalization**

- Goal To adjust for large changes in 3M's v35 to v36 APR DRG weights and to avoid large shifts in payments
- Reasons for changes in weights
  - First data set composed of ICD 10 only claims
  - Changes in hospital utilization, charges and cost in 3M dataset
  - Changes in distribution between SOI 1/2 versus 3/4
- Solution Calculate a normalization factor that will be applied to 3M's v36 APR DRG weights



## **APR – DRG v36 CMI Normalization**

#### Calculation of Normalization Factor

Avg. APR DRG Weight Under v35	Avg. APR DRG Weight Under v36	Normalization Factor

0.8713	0.6485	1.3434



- Cost to Charge Ratio (CCR) and Wage Index - Handout #3
  - CCR Methodology unchanged
  - Provider-specific file used for CCRs
  - CMS final rule used for wage index, reflecting all adjustments including reclassification
- Wage Index assignment for out of state border status hospitals updated
  - Historically, border hospitals received the state-wide wage index for the state in which the provider is physically located
  - Going forward, border status hospitals will receive an individually-applied wage index based on CMS public use files



- Rate Year 2020 HCRIS Cost Report and GME Add-On Percentage – Handout #6 and Handout #7
  - Handout includes all cost reports used in rate year 2020
  - GME methodology unchanged
  - Handout reflects GME cost as a percentage of total cost (% GME)



- Revenue Code Crosswalks Handout #4 and Handout #5
  - Methodology unchanged
  - Medicare-based cost center grouping with additional logic for Medicaid NICU grouping



- Development of 2020 rates is ongoing
- **D** Standard rate year review items include:
  - Inpatient outlier payment parameters (including trimpoint and thresholds)
  - Policy adjustors
  - Border status for non-acute care hospitals (Psych, Rehab, LTAC)
  - Use of normalized national weights
- Target Rate Setting Timeline
  - August/September 2019

### **PPR Dashboard**

**D** Registration and Access Process:

- 1. Register using registration link
- 2. Post-registration DHS approves or denies registrants
- Navigant creates an account for each approved user and sends out user login credentials via an encrypted email
- 4. New user enrolls and changes password
- 5. User now has access to interactive dashboard



Frequently Asked Questions (FAQ)
What if I forgot my password or username?     After enrolling in the NCI Password Reset Portal and waiting 24 hours, go to:
<ul> <li>a. Forgot Password/Reset Password link (You must be enrolled first): https://www.ureset.com/uReset.Web/NCILOCAL/Wizard/Reset</li> <li>b. Change Password/Expired Password: https://www.ureset.com/uReset.Web/NCILOCAL/Wizard/Change</li> </ul>
After how many days will my password expire?     Passwords expire automatically after 90 days. You will be required to reset your password at this point.
How long is the automated log out?     After 15 minutes of inactivity, the website will automatically log out.
• Part of the image/table looks like it is cut off. How do I fix that? Each element is displayed in a box that can be expanded or shrunk to fit the data, this can be done via webpage zoom. Webpage zoom is adjusted by pressing the control and plus key ("CTRL" and "+") simultaneousl control and minus key ("CTRL" and "-").

## **PPR Dashboard FAQ**

- **Troubleshooting FAQ:** 
  - Confirm that your organization does not block the PPR Dashboard website
  - Save username and password in a secure and safe place
  - Bookmark dashboard login page
  - Password must be changed every 90 days
  - In order for data to populate, you must select a time period filter (see previous slides)
