### About this document

This document describes the changes between Enhanced Ambulatory Patient Groups (EAPG) version 3.12 and version 3.13. We received many external comments and suggestions for EAPG v3.13 and gave very careful consideration to each. During this process, we held many discussions with requesters to further understand their requests and to gather additional information about their applications and their needs. Where necessary in support of the coding changes, clinical consultants in different clinical, surgical, and significant procedure specialties were consulted. A tabular summary of all the coding changes is provided in a separate spreadsheet.

# Chapter 1: Application interface changes

There are no application interface changes for v3.13.

## Chapter 2: Structural changes/new features

Other than the following standard grouper retention items, there are no additional structural changes or new features for v3.13:

- The EAPG grouper version 3.13 contains versions 3.8 through 3.13; six years' worth of grouper versions are retained (2013 through 2018).
- Grouper Versions 3.4, 3.5, 3.6 and 3.7 remain in the grouper component through 2018 for historical claims processing; however, code set updates are not included. Effective January 1, 2019, versions 3.4 through 3.7 will be removed from the component.
