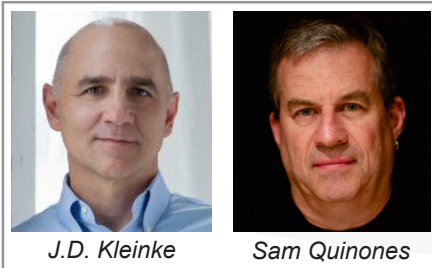

Registration is now open for the 2017 Wisconsin Rural Health Conference, June 21-23, at Glacier Canyon Lodge at The Wilderness Resort in Wisconsin Dells. This annual event is the statewide forum for examining the issues that impact small and

project. Knowledge about quality improvement tools and principles can increase the likelihood that a physician will be more successful in and comfortable with his/her leadership role.

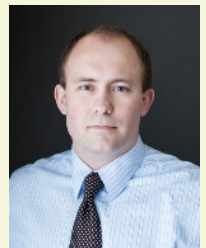


### New Legislator Profile:

#### Rep. Ron Tusler (R-Harrison)

Rep. Ron Tusler was inspired to serve in the Legislature by the example set by his great-grandfather, Sen. Gordon Bubolz. Sen. Bubolz served in the Wisconsin state senate and was best known for his conservation of Northeast Wisconsin's state parks, including High Cliff State Park.

"I love my country, state and hometown. I never served in the military, but I feel that I owe our state and country a great debt," Tusler said. "Serving in the Legislature is an effort to do my share for a state that has given me so much."

Tusler has personal experience with Wisconsin's high-quality health system, as his mother has been battling cancer.

"Anybody who has been sick knows how important our health system is. We all need it," according to Tusler. "What we are doing in Wisconsin in health care is remarkable."

## Governor Visits Three Hospitals to Celebrate Project SEARCH

Gov. Scott Walker visited three hospitals to highlight the success of workforce development initiatives, such as Project SEARCH that work to employ people with disabilities. Walker visited HSHS St. Vincent Hospital in Green Bay, Aspirus Riverview Hospital in Wisconsin Rapids, and Mayo Clinic Health System in Eau Claire. Project SEARCH teaches students marketable, transferable and competitive skills to help them transition into Wisconsin's workforce. Several Wisconsin hospitals and health systems in the state support Project SEARCH.

"A top priority for us as we continue to move Wisconsin forward is rewarding work," Governor Walker said. "This means removing barriers to work so that anyone who wants a job can find a job—and a good-paying career. We know a strong Wisconsin workforce is one that celebrates and promotes the unique abilities and talents of all employees, including those with disabilities. Workforce development

programs like Project SEARCH help make this a reality by providing students with disabilities with the practical skills and experience they need to thrive in the career of their choice."

During the most recent federal fiscal year, 4,615 people with disabilities entered Wisconsin's workforce, helping to drive the state's disability employment rate up to 41.2 percent. According to the 2016 Annual Disability Statistics Compendium, Wisconsin ranks among the top ten states in the nation for employing people with disabilities.

### WHA Offering Education on Newly Available Expedited Physician Licensure Process

#### *Interstate Medical Licensure Compact process is now operational*

With the Interstate Medical Licensure Compact's voluntary expedited licensure process becoming operational this month, WHA will be offering a 45-minute webinar on how the new Compact process can help physicians more quickly receive a Wisconsin medical license or a license in another state if the physician already holds a medical license in a Compact state. WHA General Counsel Matthew Stanford will present information on eligibility, which states are participating in the Compact, completing the application process, fees, how to maintain a Compact expedited license and considerations for utilizing the Compact expedited process versus the traditional licensure process.

The webinar, scheduled Tuesday, May 23 from 12:00-12:45 pm, is being offered through a partnership between WHA and the Wisconsin Medical Group Management Association (WMGMA). Wisconsin joined the Interstate Medical Licensure Compact through the enactment of legislation in December 2015, which was a key legislative priority for WHA. He said Wisconsin is not known for “patting ourselves on the back,” instead “we just set new goals for excellent care.”

Tusler pointed out Wisconsin’s low uninsured rate, access to care and the fact that “anyone who really needs care, for the most part, is receiving it.”

“We have a lot to be proud of in this state, and we’re thankful for our nurses, doctors and everyone involved in the health care profession,” he added.

Tusler is a strong supporter of the Rural Wisconsin Initiative, a package of legislation designed to address needs for rural communities including health care, workforce, technology and education. Part of that package, developed in close cooperation with WHA, will provide additional funding for training opportunities for advanced practice clinicians and allied health professionals.

“If we can get some professionals to start their careers in rural Wisconsin, and give them an incentive on a small scale, the kind of program we are developing has a lot of potential,” Tusler said. “Rural Wisconsin is where many opportunities exist.”

Tusler said high-quality health care is instrumental in attracting new industry and business to the state.

“When a business looks to build, they look at the services that are available,” Tusler said. “I think health care is definitely a factor important to businesses staying in our state and being successful. I also think companies are aware of how important good health care is to them.”

Tusler has experience working on emergency detention cases on behalf of the state public defender’s office. He knows some of the issues involved and the importance of getting people the mental health services they need.

“The underlying mental health issues are much more prevalent than people realize, at younger ages and even in later years,” he said. “Identifying those issues early on saves lives.”
