## Statistics on alcohol use in Wisconsin, according to the Wisconsin Department of Health Services (DHS):

- Wisconsin ranks third in the country for the percent of adults who currently drink alcohol (64.4), behind New Hampshire (64.6%) and Washington D.C. (68.7%)
- In recent years, heavy drinking in WI cost over \$4 billion, caused 2,485 deaths, and resulted in over 79,000 hospitalizations annually
- In any given year over the last 10, 9-10% of Wisconsinites over age 18 had an alcohol use disorder. Fewer than 10% of those received evidence-based treatment
